## NOTICE OF EXERCISE OF OPTIONS

A Ryder Capital Limited Initial Option (RYDO) is exercisable at \$1.25 per RYDO Option on any business day from the date of grant to 10 December 2018 (inclusive) but not thereafter. Upon the exercise of an RYDO Option, the Company will issue holders 1 Secondary Option (RYDOA) for every 1 RYDO exercised. Each RYDOA Option is exercisable at \$1.50 per RYDOA Option on any business day from the date of grant to 10 December 2021 (inclusive) but not thereafter.

The Company will apply to have the RYDOA Options listed on the ASX (in accordance with ASX listing rules) at the earlier of the expiration of all RYDO Options (10 December 2018), or the date on which all RYDO Options have been exercised, whichever is first.
